There are a wide array of fantastic parks throughout Iowa City, but nothing that really helps our citizenry within the Downtown District. Just like whitespace on a well-designed page, a green space would act as a tranquil break from all of the concrete, metal and brick of downtown.

I imagine a small park with varying levels of hills, topiary and trees. Perhaps even prairie-based plants so not as much upkeep is required. The change in landscape, instead of extra urban-scape, would allow children to stretch their imagination without the need for play equipment. 

The Proposed Irving Weber Memorial Project

This is a mult-use proposal for how the property recently acquired by the City of lowa City (the original city Hall grounds and civic center) might best be utilized to enhance our downtown for all citizens and especially retired adults who sometimes fail to receive recognition as artists and artisans, not to mention their prominent role as community volunteers who make our city function more efficiently.

The proposal is named the **Weber Memorial Project** honoring the memory of Irving Weber, longtime city historian and honored local citizen. The proposal has **three parts:** The first part, **Weber Plaza**, is a park-like green space located on the southern half of the now city-owned property, hovered over by a colorful three story mural on the east building wall adjacent to the property.

The second part, **Weber Place**, is a multi-story affordable housing project on the northern part of the lot, designed for a retired or soon-to-be retired age group as residents, modeled after the Ecumentical Towers project. That well-managed housing project dating from 1974, houses 81 apartments where residents pay annual rent equal to 30% of their adjusted gross annual income. For all residents whatever their income, that amount is fixed. And that program has been successful from the start. There are currently no vacancies and the average waiting period for occupying vacancies is currently 12 months, which definitely indicates the need for affordable housing downtown. Ideally, the Ecumenical Towers (a private entity supported by 12 local churches) might be the sponsor of Weber Place and an inquiry toward that end has been initiated; but the likelihood is that a combination of public, private and grant resources would be in a better position to move such a project and that is a matter for the city fathers to determine, but it seems that both the green space idea and especially the need for affordable housing are matters of considerable public interest and support.

And finally there is a third part to the Weber Memorial Project, to add to the Weber Plaza and Weber Place, and that is the city acquisition of the old mortuary property on Linn street, for additional affordable housing OR to remodel and to construct within the three floor levels of the old building a new feature called **Weber Creates**, a collection of artisan studios for painters, printers, ceramicists silver smiths, voice and piano teachers,, jewelry and dress makers and the list goes on, for reasonable rental fees, under the jurisdiction of the City Parks and Recreation Commission. What better way to augment lowa City's downtown entrepreneurial reputation as rhe Arts and Entertainment center for much of lowa?
